There is also a section on finite, countable and infinite sets. This chapter can be used to provide some practice in proofs, or covered quickly, or used as background material and returned to later as necessary. Chapter 2 presents the properties of the real number system. The first two sections deal with Algebraic and Order properties, and the crucial Completeness Property is given in Section 2.3 as the Supremum Property. Its ramifications are discussed throughout the remainder of the chapter. In Chapter 3, a thorough treatment of sequences is given, along with the associated limit concepts. The material is

of the greatest importance. Students find it rather natural although it takes time for them to become accustomed to the use of epsilon. A brief introduction to Infinite Series is given in Section 3.7, with more advanced material presented in Chapter 9.
